#### **JOB DUTIES AND RESPONSIBILITIES:**

- Safe and efficient operation of heavy and light equipment (motor grader excavator, loader, backhoe, gravel truck, and other equipment as required).
- Perform minor servicing and maintenance of equipment.
- Assist with flood control and repair.
- Perform manual labour as required.
- Compliance with the Lamont County health and safety program.
- Accurate recording and submission of weekly timesheets.
- Other maintenance related duties as assigned.

### **QUALIFICATIONS AND REQUIREMENTS:**

- Extensive experience in the operation of a heavy and light equipment.
- High School Diploma or GED.
- Able to lift approximately 50 lbs, sit for prolonged periods, climb in and out of equipment.
